In the Circular cited above dated 12th October 2007, a facility has been introduced for manufacturers / suppliers / distilleries to obtain KSBCL Liquor Trade Data on the KSBCL Website, by means of subscription as follows:

- "(i) Annual subscription at the following rate;
 - (a) Rs. 10,000 for monthly turnover up to Rs. 1 crore
 - (b) Rs. 50,000 for monthly turnover exceeding Rs. 1 crore and up to Rs. 5 crore
 - (c) Rs. 1,00,000 for monthly turnover above Rs. 5 crore (turnover for this purpose shall be the turnover for the month of July 2007 or the highest turnover in any month up to June-2008 whichever is higher).

AND

(ii) Monthly subscription at the following rates payable weekly;

0.02% of the weekly turnover. (The turnover for this purpose shall Be the purchase value as calculated for weekly payment)"

Suppliers who have more than one manufacturing unit have requested to club their several manufacturing units (sister concern) into one and to collect the annual subscription fee on the basis of unit which is making the highest turnover.

In view of the above request, modification to annual subscription are as follows:

The annual subscription fee for the suppliers who have more than one manufacturing unit will be on the basis of unit which is making the highest turnover among the group in any month during the excise year, while the weekly charges will be collected on the overall turnover at 0.02% of the group.

This comes into effect retrospectively with effect from 01.07.07.
